



# THE BUSINESS CENTER Highlights

- **September, 2021 August, 2022** Educated and served 1,205 youth on starting a business, career development (through an HBCU College Fair at Martin Luther King High School) and financial literacy in the public and charter schools through workshops and online course instruction.
- June, 2022 November, 2022 TBC partnered with the Global Entrepreneurship Week, Urban League and Eastern Minority Supplier Development Council to facilitate a Pitch Competition focused on food companies. There were 15 participants and 3 winners. The prize money totaled over \$8,000 and marketing services valued at over \$5,000.
- **July, 2022** Became a Verizon Small Business Development Partner to serve 150 small businesses with free webinars, coaching and industry networks.
- **September**, **2022** Developed an Oats Partnership with AARP to increase digital literacy amongst 225 older adults.
- October, 2022 Provided seminars on Growth Strategies for Businesses ready to scale and Business Planning for Entrepreneurs during Minority Economic Development Week.
- **November, 2022** Partnered with EMSDC and Habitat for Humanity to construct a Contract Small Business Incubator Program.
- October December, 2022 Coached and educated approximately 50 business owners of color on filing and completing tax applications by conducting workshops providing one on one coaching and appearing on WURD twice during drive time. TBC also trained and coached 395 small businesses of color on business development.
- December, 2022 TBC celebrated an in person the Annual Best Practices in Action and recognized 2 adult business community members, 1 educator and 2 participants for outstanding youth entrepreneurship community impact and achievement. TBC also provided a networking opportunity at the beginning of the event. Lastly panelists Kelly Garry Burks, CEO of Management Solutions Consulting Group, Lin Thomas, Chairman and CEO of Supra Office Supplies and EMSCO Scientific Enterprises, Inc., Timothy Roseboro, Vice President and Sr. Business Consultant, JP Morgan Chase Bank. The topic was "Scaling for Sustainable Growth in Philadelphia and Beyond."
